### Minutes of the January 14, 2021 Hybrid Meeting

The meeting was called to order at 3:03 pm by Ms. Tully acting as president.

The minutes of the previous meeting were reviewed. Ms. Overton moved to approve the minutes as submitted. Mr. Silcox seconded the motion, which was approved unanimously.

### Election of Officers

Ms. Tully called for nominations for the office of president. Mr. Silcox nominated Ms. Tully. Ms. Overton seconded the nomination. No other candidates were nominated. Ms. Tully was elected as president unanimously.

Ms. Tully called for nominations for the office of treasurer. Ms. Jones nominated Mr. Silcox. Ms. Overton seconded the motion. No further nominations were made. Mr. Silcox was elected unanimously.

Ms. Tully appointed Mr. Silcox to chair the Finance Committee. Ms. Tully called for volunteers to join the Finance Committee. Ms. Jones and Ms. Counihan volunteered.

Ms. Tully created a strategic planning implementation committee, but did not appoint a chair.

Ms. Tully appointed Ms. O'brien as the representative to the Friends of the Kent County Public Library.

Ms. Tully appointed Ms. Overton and Ms. Tully as representatives to the Foundation for the Kent County Public Library.
